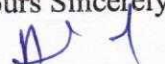

ORDER

The GST Council, Government of India in its 23rd Meeting held on 10-11-2019 had recommended for reduction of the GST rate to Research Institutes other than hospitals from 18 % to 5% (Ref 1). Further, this is endorsed by a Government order of Ministry of Finance, Government of India (Ref 2) and the concession rates for the materials applicable used for the research work are as follows;

- Scientific and technical instruments, apparatus (Including the computers).
- Accessories, part, consumables, chemicals and live animals (Experimental purpose only with CPCSEA permission).
- Computer softwares, CD-ROM, recorded magnetic tapes, microfilms, microfiches.
- Prototypes (Aggregate value of which should not exceed Rs:50,000-00 in a FY).

Permission of the University is accorded to have the reduction in GST from 18 % to 5 % on above said purchases for research purpose only. The concerned indenters need to produce the exemption certificate in the prescribed format as Annexure-1 in the official letter head. The concerned indenters are instructed to maintain the documents related to claim of reduction of GST.
